I understand that my Personal Data will be retained by Sheep Ireland in conjunction with the Sheep Data and I specifically consent to my Personal Data being used in this way and being published. - (c) consent that upon request from Sheep Ireland, I will make my flock available for a flock visit during a working day within the following two weeks. During this visit, Sheep Ireland staff may request to be accommodated to record traits required for the LambPlus program. I understand that failure to provide consent may result in my flock not receiving EuroStar evaluations for the rest of the LambPlus year.
- (d) acknowledge that **Euro-Star evaluations will only be provided for my sheep when I have met the minimum performance recording criteria as set out by Sheep Ireland annually.** In event of me failing to meet the minimum recording criteria set out by Sheep Ireland and not getting Euro-Star evaluations for my sheep, **I acknowledge that my LambPlus subscription fee will NOT be refunded.**

# 2019 PAYMENT DETAILS

For breeders of breeds that use the Sheep Ireland database to host their society flockbook (Belclare, Beltex, Charollais, Galway, Rouge de l'Ouest, Texel & Vendéen) the LambPlus fee is €50 (**Group 1**). For breeders of all other breeds the fee to join LambPlus is €100 (**Group 2**). This higher fee is due to the increased administration. If you have breeds in group 1 and group 2 the higher rate applies. Hill flocks and commercial flock are free for 2019. Cash payments are not accepted.
